## **PUBLIC NOTICE**

Pursuant to 42 C.F.R. §447.205, the Department of Human Services (DHS), Med-QUEST Division (MQD) hereby notifies the public that MQD intends to submit a State Plan Amendment (SPA) to the Centers for Medicare and Medicaid Services (CMS).

Hawaii intends to cover diabetes prevention services as outlined in the Centers for Disease Control and Prevention (CDC) recognized National Diabetes Prevention Program (NDPP) effective July 1, 2024. The NDPP is an evidence-based, educational and support program designed to assist at-risk individuals from developing Type 2 diabetes. Diabetes services are provided as a preventive service pursuant to 42 C.F.R Section 440.130(c) and must be recommended by a physician or other licensed practitioner of the healing arts within their scope of practice under state law to prevent diabetes, prolong life, and promote the physical and mental health of the beneficiary.

Hawaii MQD is submitting SPA 24-0002 to describe the Diabetes Prevention Program services and payment methodology. The description of the program services and coverage are located in Supplement to Attachment 3.1-A and 3.1-B pg. 4b-4c. The payment methodology is described in Attachment 4.19-B pg. 1.2.

Under Provisions of federal law, the state is required to issue public notice of proposed changes in statewide methods and standards for setting Medicaid payment rates. This SPA is expected to have minimal effect on the annual aggregate expenditures in Hawaii to.

The CDC-recognized organization will supervise Lifestyle Coaches and must ensure that the individual Lifestyle Coaches providing NDPP services on behalf of the organization have been formally trained and have complied with the requirements outlined by the CDC.

A Lifestyle Coach may be a physician, non-physician practitioner, or an unlicensed person who has received formal training on CDC-approved curriculum and is recognized as having met the NDPP requirements specified in the CDC's Diabetes Prevention Recognition Program (DPRP) standards and guidelines.

Lifestyle Coaches will work with Medicaid members to provide them with a culturally appropriate practical understanding of the positive impacts of healthier, sustained dietary habits; increased physical activity; behavior change strategies for weight control; and will offer at a minimum the following services with the goal being to prevent Type 2 diabetes:

- Counseling related to long-term dietary changes, increased physical activity, and behavior change strategies for weight control; and
- Counseling and skill building to facilitate the knowledge, skill, and ability necessary to prevent the onset of Type 2 diabetes.
