NOTICE FOR A PUBLIC NOTICE ON MEDICAL RESPITE RATES, NON-EMERGENCY MEDICAL TRANSPORTATION RATES and KAU 'AI PONO: SEASON OF EATING WELL PILOT RATES

In accordance with the public notice requirement of Title 42, Section §447.205 of the Code of Federal Regulations, the State of Hawaii, Department of Human Services (DHS), Med-QUEST Division (MQD), hereby notifies the public that MQD intends to submit a rate methodology for medical respite services provided under Hawai'i QUEST Integration<sup>1</sup> to the Centers for Medicare and Medicaid Services (CMS). Under provisions of federal law, the state is required to issue public notice of proposed changes in statewide methods and standards for setting Medicaid payment rates.

#### **PURPOSE**

The purpose of this posting is to provide public notice regarding the proposed rate methodology for medical respite services, non-medical transportation (NMT) for health-related social needs (HRSN), and the Kau 'Ai Pono: Season of Eating Well pilot.

#### **OVERVIEW OF PROPOSED RATE SETTING**

Three new services will be added. Two are permanently added: medical respite, within the Community Integration Services Plus (CIS+) program, and NMT for HRSN services, including CIS+.<sup>2</sup> In addition, MQD will implement a short-term pilot program, called the Kau 'Ai Pono: Season of Eating Well, for fruit and vegetable prescription boxes or protein boxes within nutrition supports.

- Medical respite services aim to provide Medicaid members experiencing or at-risk of experiencing homelessness with a safe place to prepare for planned procedures or treatments or to recover and heal following discharge from an institution. Medical respite services provide short-term housing alongside limited clinical or supportive services to members with eligible medical, psychiatric, or substance use disorder-related needs. Medical respite services are expected to increase the annual aggregate expenditures/reimbursement/payment for medical respite providers by \$14 million under QUEST Integration.
- **NMT for HRSN** will provide members with transportation to and from HRSN services, including CIS+. NMT for HRSN is expected to increase the annual aggregate expenditures/reimbursement/payments for transportation by \$12 million.
- The Kau 'Ai Pono: Season of Eating Well pilot will supplement eligible members' diets with nutritious fruits, vegetables, and proteins. To participate in the pilot and receive its benefits, members must meet social and clinical criteria as outlined in the Section 1115 Demonstration approval. The pilot is expected to

increase the annual aggregate expenditures/reimbursement/payment for services by \$4 million.
