### **Kajitōk Ko Rekūt**

1. Ta idin jorrāān eo kin public health im ewi wāween an kar jelōte ro rej uwaan injuran eo?

**Ilo kar jinoin COVID-19 pandemic, federal government ekkar kōjellā ewōr juon public health emergency (PHE). Ilo ien PHE, opij ko an Medicaid einwōt QUEST Burokraam in Integration (Hawai`i's Medicaid) ekkar jab jolok etan armij ro rej uwaan injuran, jekdoon ñe emōj an otkak an juon maron tōbrak. Ilo December 2022, Congress ear kōwebben legislation im ekkar kōjenolok mennin aikuj eo kin an wōnmaanlok Medicaid jen COVID-19 PHE innem ekkar kwalok ke mennin aikuj eo kin an wōmaanlok enaj bōjrak ilo March 31, 2023, jekdoon raan ko an PHE.**

2, Ta eo armij ro rej kōjerbal injuran eo maron kāt māne ilo ien madmōd in bar jino kōkkāāl April 2023?

**Madmōd in kōjellā eo enaj kōmman iomwin one-year jino ilo April, 2023 im bōjrak ilo March, 2024. Kin an lab joñan armij ro rej kōjerbal injuran eo ilo ien in-elablok jen 465,000+ ñan raiinnin-ejab aoleb Ro rej kōjerbal injuran eo renaj loe kōjellā eo ilo juon wōt ien. - Jino ilo April, lale an iwōj kilin letā kalor pink kin juon letā kalor pink im enaj lewaj kōmelele ko kin wāween bar kōkkāāl am maron tōbrak ñan injuran. Letā kalor pink eo emaron aikuj am uwaake ñan an maron wōnmaanlok injuran in taktō eo. Lolorjak am riiti letā eo im loor aoleb kōmelele ko, elañe ekkar.
- Ñe kwōj aikuj injuran bōtab ejako am maron tōbrak ñan Med-QUEST, jouj im lale ibben jikin jermal eo am ñe kwōmaron tōbrak ñan injuran in taktō.
