SUBJECT: CORRECTION TO INTERIM CARIES ARRESTING MEDICAMENT APPLICATION
D1354

The Med-QUEST Division (MQD) is issuing this memorandum as a correction to Memo No. FFS 18-09 and CTR 1806 dated December 27, 2018.

Silver Diamine Fluoride (SDF) is only a benefit for age 20 years and under. The original memo incorrectly indicated that it is a benefit for 21 years and under.

With the exception to all references to age 21 years, the memo remains the same as the December 27, 2018 version:

- (1) Reimbursement rate change for D1206 and D1208.
- (2) Silver Diamine Fluoride (SDF) – New benefit for age 20 years and under.

A. Topical Application of Fluoride Varnish and Topical Application of Fluoride

The reimbursement rate for Topical Application of Fluoride Varnish (D1206) and Topical Fluoride Application (D1208) will increase from \$4.16 to \$14.16 on Oahu and \$5.37 to \$15.37 on the Neighbor Islands. Frequency and age limits will remain unchanged.

B. Silver Diamine Fluoride

SDF is an antimicrobial agent considered to be a temporary measure to arrest and delay the progression of caries. It can be used when traditional methods of restoration are not

available or are contraindicated due to patient safety or behavioral concerns (e.g., combative/uncooperative/extremely apprehensive pediatric patient, cognitive disabilities, etc.). It is within this context that reimbursement will be denied or recouped when D1354 is used in conjunction with any definitive restorative procedures placed on the same tooth within 30 days of application.

Conditions for reimbursement for SDF are as follows:

1. Billing

- a. Use CDT code D1354 - Interim caries arresting medicament.
- b. The D1354 code is limited to the use of SDF only.
- c. Reimbursement for D1354 is allowable for eligible beneficiaries 20 years old and under.
- d. D1354 is reimbursed per tooth. Tooth/Teeth number(s) must be indicated on the claim form.
- e. Eligible teeth: A-T; 2-15, 18-31 (teeth 1, 16, 17, and 32 are only permitted if functional).
- f. Reimbursement for D1354 is limited to one application/tooth/day and allowed up to two times per tooth within a 12-month period.
- g. Per tooth reimbursement for D1354 is \$6.33 (Oahu) and \$6.96 (Neighbor Islands).

2. Limitations

- a. Benefit may only be allowed on functional third molars when clinically necessary. A narrative is required in those situations.
- b. Reimbursement for D1354 will be recouped when a restoration (e.g., D2140 – D2954) is placed on the same tooth within 30 days of the date of service. SDF is not meant to be billed when used as a liner, indirect medicament, or when traditional methods of restoration are practical.
- c. Fluoride varnish if billed when used in conjunction with SDF, remains subject to age (20 years old and under) and annual beneficiary topical fluoride frequency limitation of twice per year.
- d. Reimbursement for D1354 will be denied when performed on patients undergoing general anesthesia on the same day in conjunction with other definitive restorative services in a hospital or surgical center.

FQHCs are being provided this memo to inform them of changes to benefit coverage and limits.
