SUBJECT: ePASRR (Electronic Preadmission Screening Resident Review)  
Additional January Webinar Trainings

The Med-QUEST Division (MQD) has successfully implemented a Web-based ePASRR application in collaboration with public and private stakeholders. This web-based application complies with the Americans with Disabilities Act (ADA) and the Supreme Court's decision in Olmstead that individuals with Serious Mental Illness (SMI) or Intellectual Disability/Related Conditions (ID/RC) not be admitted to a Medicaid certified nursing facility (NF) until a full assessment is made.

To ensure compliance with PASRR requirements, all individuals that apply for admission to a Medicaid-certified Nursing Facility are required to be processed through this Web-based application. Neighbor islands (Hawai'i Island, Kaua'i, Lana'i, Mau'i and Moloka'i) launched the application on December 11, 2017. O'ahu will start using the electronic web-based application on February 1, 2018.

Prior to the O’ahu “Go live” date of February 1, 2018, and to reinforce the use of the ePASRR application, Health Services Advisory Group, Inc. (HSAG) and the MQD is offering additional Web-based trainings in January:
