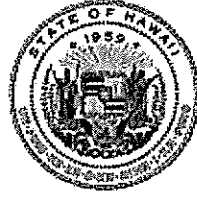

SUBJECT: NATIONAL DRUG REBATE AGREEMENT PARTICIPATION

As you are probably aware the Centers for Medicare and Medicaid Services (CMS) issued a Final Notice on March 23, 2018 that required drug manufacturers to sign and submit an updated National Drug Rebate Agreement (NDRA) by September 30, 2018. Unless manufacturers sign and submit an updated NDRA by the due date, the manufacturer will be terminated from participation in the Medicaid Drug Rebate Program (MDRP).

Therefore, based on information received from CMS which was updated on October 1, 2018, Med-QUEST Division (MQD) will not cover drugs of pharmaceutical manufacturers who have not signed the updated Medicaid NDRA.

If the NDRA is not updated by the drug manufacturer by the September 30, 2018 deadline, it is terminated on October 1, 2018 from the MDRP. A delay before re-entry is in section 1927 (b)(4)(C) of the (Social Security) Act: The manufacturer is prohibited from entering into another rebate agreement for at least one calendar quarter since the date of the termination. This will

result in the drug of the terminated manufacturer to deny when processing a claim with an error message of "NDC not covered" for at least one full quarter after the updated NDRA is submitted to CMS.

Attached is the latest update from CMS of the pharmaceutical manufacturers who have not yet signed the updated Medicaid NDRA. There are now only fourteen (14) manufacturers who still need to sign the agreement (and have not proactively indicated to CMS that they do not intend to sign). Twenty-three (23) manufacturers also found on the attachment do not intend to sign the updated agreement.
