SUBJECT: MEDICAID ELIGIBILITY FOR FREELY ASSOCIATED STATES UNDER THE COMPACT OF FREE ASSOCIATION (COFA) CITIZENS

The Med-QUEST Division of the Hawai'i Department of Human Services is strongly committed to ensuring every Hawai'i resident has access to quality health care. That's why we're glad to report that beginning December 27, 2020, Hawai'i residents who are citizens of one of the Freely Associated States under the Compact of Free Association (COFA), have been eligible for Medicaid. This means citizens of the Republic of the Marshall Islands, Republic of Palau, Federated States of Micronesia who reside in Hawai'i can now receive the same benefits as any other Medicaid beneficiaries in our state. Please note this is not a limited or special coverage program. Coverage is for the same Managed Care health plans that others in our community are members of.

This significant, new milestone was the result of more than two decades of relentless advocacy and we appreciate Hawai'i's current congressional leaders for networking with their colleagues in Washington D.C. to take this important legislation across the finish line. The resulting law reduces health access disparities in communities and enhances health equity in our aloha state.

As a healthcare provider, you play a vital role in ensuring these Hawai'i residents receive Medicaid coverage. If you have any patients or their family members, keiki to kūpuna, who are
