SUBJECT: EXPANSION OF CLAIM REFERENCE NUMBER (CRN) IN ENCOUNTER SYSTEM

The purpose of this memorandum is to notify the Health Plans that effective March 16, 2016, CRNs generated in our Encounter System will now increase from 14 digits to 15 digits, in order to accommodate a 3 digit line number. The reason for the change is to allow encounters with up to 999 lines to adjudicate in our system. Previously, the Health Plans were required to split encounters with more than 99 lines. This change would eliminate the need to split these types of encounters.

The encounter output files affected will be the 277U, 241 pended file, and the EC97R179 (Duplicate CRN) report. The only actual record layout change will be to the 241 file. The updated record layout is attached. Any Replacement or Voids in encounter submissions should not be affected because it requires only the 12 digit CRN without the line number.

Health Plans were notified of the testing period by Ms. Wileen Ortega and should begin their testing if they have not done so already.

The updated Health Plan Encounter Manual will be available on our Med-QUEST website by March 16, 2016.
