SUBJECT: FEE FOR SERVICE HOSPICE NURSING FACILITY CARE RATES
EFFECTIVE JULY 1, 2016 THROUGH DECEMBER 31, 2016

Please find the Medicaid Fee-For-Service (FFS) hospice nursing facility care rates for all participating Medicaid hospice providers.

The rates attached are based on the assumption that all Hospice providers in the State of Hawaii have complied with the Quality Assurance regulations as stated in the CMS memorandum. The rates are effective for service dates starting on or after July 1, 2016.

OAHU AND NEIGHBOR ISLAND HOSPICE NURSING FACILITY CARE RATES

Under current regulations, the Medicaid agency reimburses Hospice provider who have contracted with Medicaid Nursing Facilities 95% of the current Nursing Facility Medicaid Fee-For-Service Rate. Nursing Facility Care is on a per diem basis.
