SUBJECT: MEDICAID FEE-FOR-SERVICE AND QUEST INTEGRATION HOSPICE RATES  
EFFECTIVE OCTOBER 1, 2024 THROUGH SEPTEMBER 30, 2025

The rates are based on the Federal Fiscal Year 2025 Medicaid Hospice payment rates issued by the Centers for Medicare and Medicaid Services (CMS) and are adjusted for the Fiscal Year 2024 wage index downloaded from CMS website. The rates below are based on the assumption that all Hospice providers in the State of Hawaii have complied with the Quality Assurance regulations as stated in the CMS memorandum. The rates are effective for service dates starting on or after October 1, 2024.
