1. Individual Provider:

- If you are an Individual provider that is not required to have an NPI, and you don't have an NPI, then you will be enrolling with the Atypical Individual enrollment type.
- If you are an Individual provider that is not required to have an NPI, but have an NPI, then you will be enrolling with the Individual enrollment type.

2. Facility/Agency/Organization (FAO):

- If you are a FAO that is not required to have an NPI, and you don't have an NPI, then you will be enrolling with the Atypical Agency enrollment type.
- If you are a FAO that is not required to have an NPI, but have an NPI, then you will be enrolling with the FAO enrollment type.
