Methodology

Managed Care
Managed Care beneficiaries are calculated as the total number of beneficiaries with paid capitation for at least part of that month. One beneficiary may fall in mulitple programs, but this report identifies a beneficiary's primary program.

Medicaid Only -- Fee-for-Service
Fee-for-Service (FFS) beneficiaries are calculated as the total number of beneficiaries who were enrolled in either the State of Hawaii Organ and Tissue Transplant (SHOTT) program or the Out of State Foster Care program.

Medicaid Only -- Medicare Savings
Medicare Savings beneficiaries are calculated as the total number of beneficiaries who were assigned to the Medicare Savings Eligibility groups for at least part of that month. This number does not include members who were enrolled in Managed Care at that same time.
