1. **State Pharmacy Assistance Program (SPAP) Eligible Medicare Part D Plans for 2011**

Twenty-three (23) plans will be available for SPAP coverage in Hawaii, of which fifteen (15) plans are continuing and eight (8) plans are new, effective January 1, 2011. Thirteen (13) previous plans are no longer available. Please see the attachment for a list of the changes, plan identification numbers, and toll-free telephone numbers.

2. **Copayment Update – Effective January 1, 2011**

Effective January 1, 2011, the SPAP will be updated with the new Part D drug copayment amounts:

- a. For Part D full benefit dual eligibles (Medicare and Medicaid) up to 100% of the Federal Poverty Level (FPL): **\$1.10** for generic/preferred multi-source and **\$3.30** for other medications.
- b. For other Part D eligibles up to 150% of the FPL: **\$2.50** for generic/preferred multi-source and **\$6.30** for other medications.

SPAP claims will continue to be processed by Affiliated Computer Services, A Xerox Company-Pharmacy Benefits Manager (ACS-PBM) without any change. Please see the table in Item 4. for a billing summary. Provider memorandums (ACS) M05-12 (dated December 23, 2005) and P06-03 (dated January 30, 2006) describe the claims process and are available at the website <http://www.himed-questffs.org>; under the Communications heading, click on Provider Memos.
