SUBJECT: ALLOWABLE BILL TYPES FOR LONG TERM CARE FACILITY SERVICES

The purpose of this memorandum is to update the allowable bill types for covered Hawaii Medicaid long-term care (LTC) facility services. This memorandum clarifies Memo No. ADM-1307 and ADMX-1308 issued on June 27, 2013, to QUEST and QExA Health Plans and applies to both claims submitted to QUEST and QExA Health Plans and to fee-for-service (FFS) Medicaid.

As stated in Memo No. ADM-1307 and ADMX-1308, QUEST, QExA Health Plans and facilities providing LTC services should cease using older bill types (17X) for sub-acute services and (61X) for Intermediate Care Facility (ICF) services.

In managed care, for dates of services November 1, 2013 or later, use the allowable types of bill and qualifying conditions listed below. For FFS, use allowable types of bill and qualifying conditions effective immediately for submitted claims. In addition, for claims that have denied due to ineffective bill-type, resubmit a hard copy claim using a bill-type identified below with a copy of the previous claim submitted or the claim number (CRN) of the denied claim.
