## **Introduction to the Hawaii Medicaid Recovery Audit Contractor (RAC)**

## **Medicaid RAC Overview**

The CMS has established the Medicaid RAC program as a method for states to promote the integrity of their Medicaid program, pursuant to requirements enacted in the 2010 Patient Protection and Affordable Care Act (PPACA). Medicaid RACs will review claims for which payment has been made under Section 1902(a) of the Social Security Act or under any waiver of the State Plan to identify underpayments and overpayments and recoup overpayments for the states - [42 CFR 455.506(a)]

The Medicaid RAC final rule includes a number of provisions that respond to key industry concerns, including these highlighted requirements:

- Medicaid RACs are limited to a three-year look-back period.
- Medicaid RACs must coordinate their RAC efforts with other audit contractors and programs.
- Medicaid RACs are prohibited from auditing claims that other state agencies or contractors have already audited for the same issue.

## Hawaii Medicaid RAC

In the coming months, the Hawaii Med-QUEST Division and Myers and Stauffer will be conducting outreach through informational webinars. Further details are forthcoming and will be posted on the Myers and Stauffer website created specifically for RAC outreach. The Myers and Stauffer Hawaii Medicaid RAC website provides access to the secure provider portal and includes a list of RAC frequently asked questions and answers as well as additional information to assist providers with understanding the RAC program.
